



This program is only possible because of the ability of 100% Platinum Grade Silicone to withstand the heat and pressure of sterilization and SquarePegToys® ongoing commitment to community and safety.

This constitutes an agreement between you and SquarePegToys® (SPT) and with your signature below you agree to the terms of the SwapIT!TM program and release SquarePegToys® from liability as defined herein.

The service provided is a way of exchanging 100% Platinum Grade silicone toys with others in a somewhat safer and secure way than has been possible until now. Toys entering this program will undergo the same sterilization process employed by hospitals to sterilize medical instruments. By your participation you acknowledge and accept that this process is also adequate for the sterilization of your silicone toys. The process includes 2 stages, cleansing the toys in an ultra-sonic bath and passing them through a standard autoclave cycle.

Any persons attempting to defraud either SPT or another swapper will be banned from the service. Program fees are non-refundable. If your swap partner fails to send their toy within 10 days then your program fees will be used to return your original toy to you.

Unwashed toys and toys with a permanent odor will be rejected and returned at the expense of the participant. There is information on the SquarePegToys® website on how to remove silicone lube and fecal odor from silicone toys.

A match code that you and your swap partner agree upon will allow us to match your exchange without you having to share personal information with anyone but SPT. Your personal information is protected under SPT's privacy policy and will not ever be shared or sold to anyone outside of SPT.

SquarePegToys® is responsible for:

- Matching toys from swap partners and getting them forwarded along once conditions are met.
- Supplying a Certificate of Sterility to each swap recipient.

Participants are responsible for:

- Working out all the details of what will be swapped between themselves.
- Each paying for a swap package.
- Getting their items to SPT safely: tracking and insurance are advised. SquarePegToys® is not responsible for toys lost or damaged before they get to us.
- Completing and signing the this swap agreement and including it with their swap items.
- Including a SwapIT!TM voucher for each toy and providing an accurate description of their toy's condition and providing a match code to SPT.

With your signature you acknowledge and agree:

- SPT is to simply act as a sterilization service and independent 3rd party to exchange the toys. All other services or responsibilities are to be considered outside the realm of this agreement.
- You will adhere to the spirit and intent of this program as presented.
- You accept full responsibility for the condition of your toy(s), declaring that to your swap partner, and you release SPT from any responsibility to verify the condition of your swap partner's toy for you.
- Program fees are non-refundable.
- Toys left after 30 days will be considered abandoned and will be destroyed.
- Final shipments go out via FedEx Ground with Signature Required. You can choose to have your final delivery left without a signature, but this will shift the responsibility of a lost or stolen package directly to you.
- Replacement value shall be limited to 1/2 of the original value of the item and issued as an SPT web site credit.
